## PLAN OF ORGANIZATION FOR THE SPRINGS MENNONITE CHURCH

### ARTICLE 1 - DUTIES & PRIVILEGES OF MEMBERSHIP

Section 1. Members shall live a holy, separated and consecrated life unto God. Members are expected to attend the services of the church regularly and support the work of the church by their time, talents and means, up to or beyond the tithe, and share in witnessing to the unsaved. To the best of their abilities, they shall be willing to serve in any capacity to which the Lord, through the church, may call them.

- A) Each candidate for membership shall be interviewed prior to being accepted into membership using the following four questions:
- 1) What has been your faith pilgrimage?
  - 2) Where have you experienced sin in your life?
  - 3) How has God taught you through those experiences?
  - 4) How is your walk with Christ now?

The interview is to be conducted by the pastor on a one-to-one basis with the potential member. (The interview will be conducted by an Elder, in the event that the membership candidate is a member of the pastor's family.) The pastor or Elder who conducts the interview will then report back to the Board of Elders as to the nature of the discussion.

Section 2. Members in this congregation are entitled to participate in all general activities of the church and are eligible to hold any office. They shall be eligible to contribute to all decision-making brought before the congregation.

Section 3. Members of the congregation are pledged to give and receive counsel from others in the church. Each member, group, and ministry of the congregation shall be accountable to the members of the congregation. Please refer to *Agreeing and Disagreeing in Love* document as prepared by the Mennonite Church USA and attached on page 35.

Following the model set forth in Matthew 18:15-17 and Galatians 6:1, as suggested by this document, if a concern or disagreement is not resolved after taking 2 or 3 witnesses, the matter should be reported to the Board of Elders.

- 94 A) Should a member become an offense to the church by reason of unchristian conduct  
95 and/or flagrant moral violation which is not repented of, the pastor and the Board of  
96 Elders may recommend to the congregation that his/her membership be terminated, but  
97 only after faithful efforts have been made to bring such member to repentance and  
98 confession.  
99 B) Members of the congregation shall continue to show Christian love and maintain a  
100 redemptive relationship with those whose membership is terminated.

101 Section 4. Withdrawal from membership

- 102 A) Any member who desires a letter of transfer and recommendation sent to any other  
103 church is entitled to such after the written request is approved by the pastor, Board of  
104 Elders, and the congregation. In case of removal to another community, such request  
105 shall be made as soon as possible after the move is completed.  
106 B) If members send written request to be released from their covenant obligations to this  
107 church, the pastor and Board of Elders, after they shall have patiently and kindly  
108 endeavored to secure the member's continuance in its fellowship, may grant the  
109 member's request with congregational approval.  
110 C) A member withdrawing by written request or in any other way losing membership in  
111 the congregation, thereby forfeits all rights and privileges to any and all properties  
112 belonging to the congregation.

113 **ARTICLE II -- THE BOARD OF ELDERS**

114 Section 1. The Board of Elders shall consist of five lay members of the congregation  
115 selected through the Gifts Discernment Process. Selections for the Board of Elders shall  
116 precede selections for any other congregational positions. The Board shall be responsible to  
117 the congregation.

118 The Elders shall be chosen by the congregation for three-year terms. These terms shall be  
119 alternated so that no more than two Elders shall be selected in any one year. An elder may  
120 serve for two full successive terms, and may again serve in the same position after having  
121 been out of office for one term. An Elder will not continue to hold or assume any other  
122 position that would result in being a member of Church Council.

123 Section 2. The Board shall select its own officers and shall meet at least once a month.

124 Section 3. The members to be chosen as Elders shall be individuals of sound judgment,  
125 with spiritual maturity, exercising good leadership, and with congregational rapport. Elders  
126 shall recognize the importance of confidentiality in many of the matters that are brought before  
127 the Board. Therefore, the call to the Board of Elders shall be considered a responsible calling,  
128 and members shall be installed by a congregational commissioning service.

129 Section 4. The Board of Elders and Pastor comprise the ministry team of the  
130 congregation, providing leadership and care to the fellowship. This team shall seek to guide  
131 the congregation in matters of doctrine, faith, and practice. The Board and Pastor shall be  
132 mutually accountable in matters regarding ministerial task. The ethical standards for the  
133 ministry team are outlined in *A Mennonite Polity for Ministerial Leadership* (© 1996.)

134 The ministry team shall be responsible in matters of discipline and/or reconciliation of  
135 estranged members in the congregation. In the absence of the pastor, the Elders shall provide  
136 pastoral leadership and care in the life of the congregation.

137 Section 5. At least six months preceding the end of the pastor's term of service, the  
138 Board of Elders, with input from Church Council shall review his/her tenure of service and  
139 make a recommendation to Church Council for congregational approval.

140 Section 6. Elders, in consultation with Church Council, are encouraged to appoint a  
141 committee to negotiate the renewal of the pastor's covenant agreement including the salary  
142 package. The package shall then be presented to the congregation for approval.

143 Section 7. The Board of Elders may appoint individuals or committees as they see fit to  
144 assist them in their responsibilities and shall review the work of these individuals or  
145 committees periodically.

146 Section 8. The Board of Elders shall select a Gifts Discernment Committee of five  
147 members of the congregation. The Board of Elders shall first review the information gathered  
148 by a gifts survey and also review names suggested by the congregation before making their  
149 selection. When the Board has achieved consensus, an Elder shall personally contact the  
150 nominee and ask for their decision. When a nominee has been selected and has shown his or  
151 her willingness to serve, their name will be submitted for congregational approval.

152 Section 9. If a conflict goes unresolved between Elders and the pastor after following the  
153 initial steps of the *Agreeing and Disagreeing in Love* document (see page 35), they may  
154 request Church Council to appoint a mediation team or suggest an alternative solution. If there  
155 is an unresolved conflict between Elders and Church Council, the Overseer should be  
156 requested to appoint a mediation team or suggest an alternative solution.

### 157 **ARTICLE III – PASTOR**

158 Section 1. The Board of Elders shall oversee the licensing and/or ordination of the pastor  
159 as suggested by Allegheny Mennonite Conference Leadership Commission.

160 Section 2. The duties of the pastor shall be as designated first by the Board of Elders and  
161 then by Article VI Section A of the Conference Constitution (2004).

162 Section 3. If additional ministerial help should be needed, it shall be recommended by the  
163 Board of Elders for approval by the congregation.

164 Section 4. The pastor shall serve as a non-voting member on all boards, councils, or  
165 committees of the congregation.

166 Section 5. At least six months preceding the end of the pastor's term of service, the  
167 Board of Elders, with input from Church Council shall review his/her tenure of service and  
168 make a recommendation to Church Council for congregational approval. The pastor shall give  
169 the congregation at least 90 days notice of his/her intention of leaving the congregation.

170 Section 6. Just as members of the congregation are pledged to give and receive counsel  
171 from others in the church, the pastor shall be accountable to the congregation through the  
172 Church Council. Please refer to *Agreeing and Disagreeing in Love* document as prepared by  
173 the Mennonite Church USA and attached on page 35.

- 174 A) Should a pastor become an offense to the church by reason of unchristian conduct  
175 and/or flagrant moral violation, Church Council may take action, or the Board of  
176 Elders may make a recommendation to Church Council that his/her covenant be  
177 terminated. Final action shall be brought to the congregation for approval.  
178 B) Members of the congregation shall continue to show Christian love and maintain a  
179 redemptive relationship with a pastor whose covenant is terminated.  
180 C) If a conflict goes unresolved between Elders and the pastor, or Church Council and the  
181 pastor, after following the initial steps of the *Agreeing and Disagreeing in Love*  
182 document (see page 35), they may request Church Council or the Board of Elders  
183 respectively, to appoint a mediation team or suggest an alternative solution.

184 **ARTICLE IV – THE OVERSEER**

185 Section 1. The congregation shall select an overseer/regional minister in cooperation with  
186 the Board of Elders and with the Leadership Commission of Allegheny Conference.

187 Section 2. The overseer’s / regional minister’s duties shall be as outlined by the Board of  
188 Elders and Article IV Section B.1.(5)(a) of the Conference Constitution.

189 **ARTICLE V – CONGREGATIONAL OFFICERS**

190 Section 1. The officers of the congregation shall consist of a congregational chairperson,  
191 a congregational secretary, and a congregational treasurer. A description of the scope of  
192 ministry for each of these officers is found in Appendix A of this document.

193 Section 2. The officers shall be selected by the congregation from the membership  
194 through the Gifts Discernment Process for a term of three years, with length of the first term  
195 of each being such that one officer will be selected each year. The officers may serve for two  
196 full successive terms and may again serve in the same position after having been out of office  
197 for one term.

198 Section 3. The Congregational Chairperson shall preside at all meetings of the Church  
199 Council and at all annual meetings of the congregation.

200 Any person holding a position in the church who wishes to resign from that post must  
201 contact the Congregational Chairperson either in person or in writing.

202 If and when a vacancy occurs in a church position, the Congregational Chairperson shall  
203 call a meeting with the Chairperson of the Board of Elders, the Chairperson of the Gifts  
204 Discernment Committee, and the Pastor. This group shall be responsible for appointing  
205 someone to fill the unexpired term of office whether the vacancy appears because of death,  
206 resignation, or extended absence from congregational life. Persons’ names who have been  
207 called to serve in a church position in this manner will be presented to the members for  
208 affirmation. At their discretion, this ad hoc committee may choose to refer the obligation to  
209 fill the position to the Gifts Discernment Committee.

210 Section 4. The congregational secretary shall keep a record of all meetings of the Church  
211 Council and the congregation, maintain all records and documents of the congregation, and  
212 perform such other duties as requested by the pastor or chairperson of the congregation.

213 Section 5. The congregational treasurer shall receive, hold and disburse funds of the  
214 congregation, keep an accurate record of all receipts and disbursements and assist the Church

215 Council in the preparation of the annual church budget. The treasurer shall perform such other  
216 duties as requested by the pastor or chairperson of the congregation.

217 **ARTICLE VI – THE CHURCH COUNCIL**

218 Section 1. The Church Council shall consist of the congregational chairperson,  
219 congregational secretary, congregational treasurer, chairperson of the Board of Elders,  
220 chairperson of the Board of Trustees, second year Adult and Junior Department Sunday  
221 School superintendents, president of the Daughters of Dorcas, an MYF representative, and  
222 two (2) at-large Council members. The council shall be responsible to the congregation and  
223 shall meet at least once a month.

224 A) The two at-large Council members shall be selected from the congregation using the  
225 Gifts Discernment process for a term of three years, alternating also with the Council  
226 Chairperson so that one person is selected each year. Whenever possible, the at-large  
227 Council members should not continue to hold or assume any other position that would  
228 result in being a member of Church Council.

229 Section 2. The council shall seek to:

- 230 A) Unify the activities of the congregation.  
231 B) Give to, and receive counsel from persons carrying responsibility in either the Sunday  
232 School, church, committees, or congregational programs.  
233 C) Assume general responsibility for the preparation and administration of the budget as  
234 approved by the congregation.  
235 D) Arrange for special meetings of the congregation.  
236 E) Determine and periodically review job descriptions for congregational positions and  
237 council appointees.  
238 F) Establish the policies and procedures of the congregation with congregational approval.

239 Section 3. The Church Council may appoint individuals, a parliamentarian, or  
240 committees as they see fit to assist them in their responsibilities and shall review the work of  
241 these individuals or committees periodically. Church Council shall hire legal counsel when  
242 deemed necessary.

243 In the case of hiring a new pastor, the Congregational Chairperson, Chairperson of the  
244 Board of Elders, and the Chairperson of the Gifts Discernment Committee, shall appoint a  
245 Pastoral Search Committee for congregational approval. This Pastoral Search Committee  
246 should include representation from Church Council, Board of Elders, and the congregation at  
247 large. The Pastoral Search Committee should conduct a pastoral search and then, they, along  
248 with Church Council, shall finalize the covenant agreement and salary package to be presented  
249 to the congregation for approval.

250 Section 4. If a conflict goes unresolved between Church Council and the pastor after  
251 following the initial steps of the *Agreeing and Disagreeing in Love* document (see page 35),  
252 they may request Elders to appoint a mediation team or suggest an alternative solution. If  
253 there is an unresolved conflict between Elders and Church Council, the Overseer should be  
254 requested to appoint a mediation team or suggest an alternative solution.

255 **ARTICLE VII – THE BOARD OF TRUSTEES**

256 Section 1. The Board of Trustees shall be composed of three members of the  
257 congregation selected by the congregation through the Gifts Discernment Process for three-  
258 year terms. Those terms shall be staggered in such a way that the term of one trustee will  
259 expire each year. A trustee shall not be eligible for another term of office for a period of one  
260 year. The Board is responsible to the congregation through the Church Council.

261 Section 2. The Board of Trustees shall have full authority and responsibility for the  
262 management and operation of real property on behalf of the congregation. A description of the  
263 scope of ministry for Trustees is found in Appendix A of this document.

264 Section 3. The Chairperson of the Board of Trustees shall be the trustee serving the third  
265 year of his or her term as a member of the Board of Trustees.

266 Section 4. The Chairperson of the Board of Trustees shall have the power to execute all  
267 contracts, agreements, leases, mortgages, notes, bonds, and deeds relating to and necessary to  
268 encumber or convey real property of the congregation. All such legal documents and  
269 instruments relating to real property shall be countersigned by the Congregational Chairperson.

270 Section 5. The Board of Trustees may appoint individuals or committees as they see fit to  
271 assist them in their responsibilities and shall review the work of these individuals or  
272 committees periodically.

273 **ARTICLE VIII – THE CEMETERY COMMITTEE**

274 Section 1. The Cemetery Committee shall be composed of three members of the  
275 congregation selected by the congregation through the Gifts Discernment Process for three-  
276 year terms. Those terms shall be staggered in such a way that the term of one committee  
277 member will expire each year. The Cemetery Committee is responsible to the congregation  
278 through the Trustees.

279 Section 2. The Cemetery Committee shall have the full authority and responsibility for  
280 the management, maintenance, and operation of the cemetery property. A description of the  
281 scope of ministry for the Cemetery Committee is found in Appendix A of this document.

282 **ARTICLE IX – GIFTS DISCERNMENT COMMITTEE**

283 Section 1. The purpose of the Gifts Discernment Committee shall be to provide active  
284 methods of discerning and developing gifts among members and to encourage the use of those  
285 talents and gifts. They shall be a resource to Church Council, the Elders, Sunday School  
286 Superintendents, and other leaders and organizations in finding persons for various  
287 assignments within the church.

288 Section 2. The Committee shall consist of five members of the congregation each with  
289 three-year renewable terms. Terms shall be alternated so that no more than two persons' terms  
290 expire in any given year. The committee shall select their own officers from within as needed.

291 Section 3. Procedure

292 A) The Gifts Discernment Committee shall develop an ongoing personnel file using a  
293 congregational gifts survey and suggested names from the congregation.

- 294 1) The congregational gifts survey shall seek to learn from and encourage each member  
 295 to express what activities he or she has interest in participating in, and where each  
 296 feels their talents lie.
- 297 2) The committee shall then ask the congregation for suggested names of persons they  
 298 see as having talents or abilities to perform the various tasks within the  
 299 congregation.
- 300 B) The Gifts Discernment Committee will use the steps below in calling persons to serve  
 301 the congregation for the following designated positions and any other positions as  
 302 called for by the Church Council and/or the Board of Elders.

  - 305     ▪ Congregational Secretary
  - 306     ▪ Congregational Treasurer

  - 311     ▪ Bible School Committee
  - 312     ▪ Retreat Committee
  - 313     ▪ HOPE Committee
  - 314     ▪ At-large Council members
  - 315     ▪ Music Committee
  - 316     ▪ Visual Arts Committee
  - 317     ▪ Librarians
  - 318     ▪ Hospitality Committee
  - 319     ▪ Conference Delegates
  - 320     ▪ Outreach Committee
  - 321     ▪ Cemetery Committee
- 322 1.) Using the congregational gifts survey and the names suggested by the congregation,  
 323 the committee shall develop a list of persons selected for service within the  
 324 congregation.
- 325 a.) Anyone appointed by the Gifts Discernment Committee to a position on the Board  
 326 of Elders must be a member of the congregation. Anyone appointed by the Gifts  
 327 Discernment Committee to a position on Church Council or a position where they  
 328 will eventually serve on Church Council must be a member of the congregation.  
 329 The Gifts Discernment Committee and Conference Delegates shall be comprised of  
 330 100% members of the congregation. Any other committee or team of advisors  
 331 must be comprised of at least 50% members of the congregation.
- 332 b.) In the case of Board of Elders:
- 333     i.) Selections for the Board of Elders shall precede selections for any other  
 334 congregational positions.
  - 335     ii.) An elder will not continue to hold or assume any other position that would  
 336 result in being a member of Church Council.
  - 337     iii.) The pastor will contact persons proposed for the Board of Elders.

- 338 2.) When the Gifts Discernment Committee agrees and has achieved consensus, the list  
339 of nominees shall be presented confidentially and individually to each Church  
340 Council member for confirmation.
- 341 a.) If any one Council member raises a question about the suitability or spiritual  
342 qualification of a name proposed, this person's name will be returned to the Gifts  
343 Discernment Committee.
- 344 b.) If an objection, question, or concern is raised, the Gifts Discernment Committee  
345 will convey this to the Elders for handling before the proposed person will be  
346 considered for any assignment.
- 347 c.) The Elders are responsible to follow through on reviewing the matter with the  
348 objecting Council member and give counsel to the Gifts Discernment Committee  
349 concerning the use of this person in church assignment.
- 350 d.) It shall be the purpose of the Gifts Discernment Committee and the Elders to seek  
351 to use all members to serve and share in some way in the life of the congregation.  
352 It shall not be assumed that a person shall be set aside because of certain problems  
353 or "growing needs" in their lives.
- 354 3.) After confirmation by Church Council, a member of the Gifts Discernment  
355 Committee will contact the proposed person (personally, if at all possible), explain  
356 the task, convey the call of the church to serve, and ask for their prayerful decision.  
357 If this person declines the proposed assignment, they will be asked what area of  
358 interest and availability they may have in serving. This will be conveyed to the  
359 Committee and become part of the information pool or personnel file.
- 360 a.) Each person confirmed by the Council is advised that he or she must yet be  
361 confirmed by the congregation.
- 362 4.) When all positions of the congregation are filled through the above process, the  
363 names will be presented to the congregation for two weeks of prayerful reflection.  
364 Any questions shall be directed to the Gifts Discernment Committee and resolutions  
365 of concerns will be sought prior to congregational approval.
- 366 a.) Any concern raised by a member of the congregation will be clarified with the  
367 person expressing the concern, and if it is determined that the cause is just, the  
368 Elders will resolve this with the proposed person before he or she is affirmed by  
369 the congregation.
- 370 b.) Ideally each person will serve with unanimous voice and support of the entire  
371 congregation.

372 C) Ongoing Assessment of Gifts

- 373 1.) The Gifts Discernment Committee shall advise the Elders, Church Council, and  
374 congregational members of needs in the congregation and prayerful suggestions will  
375 be solicited.
- 376 2.) The Gifts Discernment Committee is encouraged to visit with persons to determine  
377 their interests, abilities, and availability before specific assignments are proposed to  
378 them.

379 **ARTICLE X – SUNDAY SCHOOL**

380 Section 1. The Sunday School shall consist of an Adult Department and a Junior  
381 Department. The Sunday School shall be a teaching program presenting Christ to people as

382 Savior and Lord, encouraging commitment to Him, and helping all to grow toward Christian  
383 maturity.

384 Section 2. There will be two superintendents for each department who will be responsible  
385 for overseeing of the department's program, the call of teachers to specific classes, and  
386 provide for any opening services. A description of the scope of ministry for the Sunday School  
387 Superintendents is found in Appendix A of this document.

388 Section 3. The superintendents shall be chosen from the membership of the congregation  
389 through the Gifts Discernment Process for alternating terms of two years for each department.  
390 The second year superintendent shall be a member of Church Council.

391 **ARTICLE XI – BIBLE SCHOOL COMMITTEE**

392 Section 1. The purpose of the Bible School Committee shall be to plan, oversee, and  
393 coordinate the summer Bible School program. The Bible School shall be a teaching program  
394 presenting Christ to people as Savior and Lord, encouraging commitment to Him, and helping  
395 all to grow toward Christian maturity. A description of the scope of ministry for the Bible  
396 School Committee is found in Appendix A of this document.

397 Section 2. The Committee shall consist of three persons selected by the congregation  
398 using the Gifts Discernment Process with three-year terms alternating so that one member is  
399 chosen each year. The chair of the committee shall be the member serving the third year of  
400 their term.

401 **ARTICLE XII – LIBRARY**

402 Section 1. The librarian shall be responsible for the selection and management of media  
403 (both print and non-print), as well as facilitating the use of the library for the congregation.

404 A description of the scope of ministry for the librarians is found in Appendix A of this  
405 document.

406 **ARTICLE XIII – HOSPITALITY COMMITTEE**

407 Section 1. The Hospitality Committee shall be responsible for preparing and serving  
408 meals for such occasions as funerals, visiting groups, and others who may need their services.  
409 The committee also gives oversight to the kitchen and kitchen supplies. A description of the  
410 scope of ministry for the Hospitality Committee is found in Appendix A of this document.

411 Section 2. The Hospitality Committee shall consist of three persons each with three-year  
412 terms alternating so that one member is selected through the Gifts Discernment Process each  
413 year. The committee shall select their own officers from within as needed.

414 **ARTICLE XIV – WORSHIP COMMITTEE**

415 Section 1. The purpose of the Worship Committee shall be to plan and oversee the public  
416 worship services of the congregation for Sunday mornings and other special occasions. They  
417 shall provide coordination between persons involved in the worship services. The worship

418 committee is responsible to the Board of Elders. A description of the scope of ministry for the  
419 Worship Committee is found in Appendix A of this document.

420 Section 2. The Worship Committee shall consist of volunteers or appointees approved by the  
421 Board of Elders each with a term of one year or longer. The committee shall select their own  
422 officers from within as needed.

#### 423 **ARTICLE XV – MUSIC COMMITTEE**

424 Section 1. The purpose of the Music Committee shall be to plan and coordinate Christian  
425 music for regular worship services and for special services as needed. A description of the  
426 scope of ministry for the Music Committee is found in Appendix A of this document.

427 Section 2. The Music Committee shall consist of three persons each with three-year terms  
428 alternating so that one member is selected each year by the congregation using the Gifts  
429 Discernment Process. The committee shall select their own officers from within as needed.

#### 430 **ARTICLE XVI – OUTREACH COMMITTEE**

431 Section 1. The purpose of the Outreach Committee shall be to plan, train, and oversee the  
432 ways that the congregation can present the community with the Gospel message, the tenets of  
433 our faith, and our openness to the community and visitors to join in our services, fellowship,  
434 and ministries. A description of the scope of ministry for the Outreach Committee is found in  
435 Appendix A of this document.

436 Section 2. The Outreach Committee will consist of three persons each with three-year  
437 terms alternating so that one member is selected each year by the congregation using the Gifts  
438 Discernment Process. The committee shall select their own officers from within as needed.

#### 439 **ARTICLE XVII – RETREAT COMMITTEE**

440 Section 1. The purpose of the Retreat Committee shall be to plan, organize, and oversee  
441 the annual church retreat. The church retreat is a weekend event to gather the congregation in  
442 a weekend of informal worship, input, and interaction. A description of the scope of ministry  
443 for the Retreat Committee is found in Appendix A of this document.

444 Section 2. The Retreat Committee will consist of three persons each with three-year  
445 terms alternating so that one member is selected each year by the congregation using the Gifts  
446 Discernment Process. The committee shall select their own officers from within as needed.

#### 447 **ARTICLE XVIII– DAUGHTERS OF DORCAS**

448 Section 1. The purpose of the Daughters of Dorcas shall be to foster the missionary spirit  
449 by aiding foreign and home missions, charitable institutions, needy within the area and to  
450 promote fellowship among its members. A description of the scope of ministry for the  
451 Daughters of Dorcas is found in Appendix A of this document.

452 Section 2. The Daughters of Dorcas organization shall include all persons who desire to  
453 participate in the organization. The Daughters of Dorcas shall select their own officers.

#### 454 **ARTICLE XIX – MENNONITE YOUTH FELLOWSHIP (MYF)**

455 Section 1. The MYF shall promote a spiritual life and fellowship among its members so  
456 that they may come to know Jesus Christ as Lord and Savior. They shall also promote local

457 youth ministry and service activities, Conference youth events, national youth convention  
458 (MCUSA) and other functions in keeping with the purpose of its organization.

459 Section 2. Membership shall be open to any young person upon entering the ninth grade.

460 Section 3. Adult supervision for the MYF shall be provided by the congregation. A  
461 description of the scope of ministry for the MYF Advisors is found in Appendix A of this  
462 document. Each year the Gifts Discernment Committee shall confidentially provide the Board  
463 of Elders with a list of persons they would propose to be MYF advisors. The Board of Elders  
464 shall review the list and forward it to the MYF indicating their approval and preferences  
465 regarding these persons. The MYF shall then return their list of preferred candidates to the  
466 Elders in order for personal contacts to be made.

#### 467 **ARTICLE XX – JUNIOR YOUTH FELLOWSHIP (JYF)**

468 Section 1. The JYF shall promote strong faith interaction between young people and  
469 advisors as well as between children and parents. They shall promote community outreach and  
470 help young people deal with everyday issues facing them.

471 Section 2. Membership shall be open to any young person, typically Grades 5 – 8.

472 Section 3. Adult supervision for the JYF shall be provided by the congregation. A  
473 description of the scope of ministry for the JYF Advisors is found in Appendix A of this  
474 document. Each year the Gifts Discernment Committee, working with the current team of JYF  
475 advisors, shall prepare a list of proposed advisors for the coming year. This list shall be  
476 confidentially presented to the Board of Elders prior to the beginning of the church year for  
477 their approval and in order for personal contacts to be made.

#### 478 **ARTICLE XXI– JUST FOR KIDS (JFK)**

479 Section 1. The JFK meetings shall be a time of fellowship, crafts, and activities that will  
480 serve to introduce children to our church family.

481 Section 2. Membership shall be open to any young person, typically Grades 1 – 4.  
482 Kindergarten students may or may not be included as the advisors see fit.

483 Section 3. Adult supervision for the JFK shall be provided by the congregation. A  
484 description of the scope of ministry for the JFK Advisors is found in Appendix A of this  
485 document. Each year the Gifts Discernment Committee, working with the current team of JFK  
486 advisors, shall prepare a list of proposed advisors for the coming year. This list shall be  
487 confidentially presented to the Board of Elders prior to the beginning of the church year for  
488 their approval and in order for personal contacts to be made.

#### 489 **ARTICLE XXII MINISTERS OF VISITATION**

490 Section 1. The Ministers of Visitation shall assist the pastor with the visitation of the  
491 elderly and shut-ins in the congregation and community. They shall meet regularly with the  
492 pastor to determine who should be visited, and to coordinate visitation duties. A description of  
493 the scope of ministry for the Ministers of Visitation is found in Appendix A of this document.

494 Section 2. The Ministers of Visitation will consist of 4 persons, each with 2-year terms,  
495 with two new members selected by the Elders each year.

496 **ARTICLE XXIII – DELEGATES TO CONFERENCE AND NATIONAL DELEGATE**  
497 **ASSEMBLY**

498 Section 1.

- 499 A) Delegates shall represent the congregation to the Conference in accordance with the  
500 guidelines prescribed in the constitution of the Allegheny Mennonite Conference. A  
501 description of the scope of ministry for the delegates is found in Appendix A of this  
502 document.
- 503 B) Delegates shall represent the congregation to the National Delegate Assembly in  
504 accordance with the by-laws of the Mennonite Church USA.

505 Section 2. The persons who represent the following congregational offices shall act as our  
506 delegates to Allegheny Conference:

- 507 A) the pastor  
508 B) the congregational chairperson, or another member of Church Council  
509 C) the chairperson of the Board of Elders, or another member of the Board of Elders  
510 D) the church treasurer, or a member of Church Council
- 511 i.) If a delegate cannot be found among the Board of Elders or Church Council,  
512 either of these groups may appoint a representative from the general  
513 membership. Whenever possible, the persons listed as B, C, & D above should  
514 serve a 1-2 year term as a delegate.
- 515 ii.) The congregation, using the Gifts Discernment Process, shall select three at-  
516 large Conference delegates from the membership for four-year terms. These  
517 terms shall be staggered so that one delegate will be selected for a four-year  
518 term in any one year.

519 Section 3. Delegates and alternates to the National Delegate Assembly shall be appointed  
520 by Church Council in accordance with Mennonite Church USA guidelines and from the  
521 following groups in descending order:

- 522 1.) Pastor and at-large Conference delegates  
523 2.) Other Conference delegates  
524 3.) Church Council and Board of Elders  
525 4.) Congregational Membership

526 **ARTICLE XXIV – MEETINGS**

527 Section 1. The congregational year shall be from September 1 through August 31. The  
528 annual congregational meetings shall be held within two months after the end of the  
529 congregational year. The Church Council shall determine the exact date and place for the  
530 meeting.

531 Section 2. A special meeting of this congregation may be called by either the Church  
532 Council or the Board of Elders. A special meeting may be called by a written request signed  
533 by ten members of the congregation and presented to either Church Council or the Board of  
534 Elders.
